1.1. Bids/Tenders are invited, for Tender Documents for the procurement of <u>Catering</u>

Services on framework contact basis from Sales Tax and Income Tax Registered manufacturers, authorized distributors, dealers and firms.

#### 2. INSTRUCTIONS TO THE BIDDERS

- **2.1.** Procurement will be made under Punjab Procurement Rules (PPRA)2014.
- **2.2.** It will be clearly understood that the Terms and Conditions mentioned in this document are intended to be strictly enforced.
- **2.3.** Bidders must ensure that they submit all the required documents indicated in the Tender / Bid Documents at the time of submission of Bids and no request for submission of missing documents will be entertained after opening of the Technical Bids.
- 2.4. Bids without supporting documents, undertakings, valid documentary evidence, and bids not conforming to terms and conditions given in the Tender Documents will be liable for rejection. Bids received after due time and date or bids without Bid Security in shape of CDR or CDR less than required amount or Bid Security in shape of Cheque/ Cross Cheque/pay order/ Demand Draft
  - /Banker's Cheque shall be summarily rejected.
- **2.5.** Vendors must quote their rates on the company letter pad / tender form according to the specifications.

#### **2.6.** Mode of Advertisement:

#### 2.7. Procedure of Open Competitive Bidding

As per PPRA Rule No. 38(2)(a) procedures shall be followed with details given below:

- 2.7.1. The bid shall comprise of a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal;
- **2.7.2.** The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion and firm name must be mentioned on each envelope.

- **2.7.3.** Initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened; The envelope marked as "FINANCIAL PROPOSAL" shall be retained in the custody of procuring agency without being opened;
- 2.7.4. The Procuring Agency shall evaluate the technical proposal(s) in a manner prescribed in this document, without reference to the price and reject any proposal which does not conform to the specified requirements as listed in said Sections. During the technical evaluation no amendments in the technical proposal shall be permitted;
- **2.7.5.** The financial proposals of technically qualified bidders shall be opened publicly at a time, and venue announced and communicated to the bidders in advance;
- **2.7.6.** After the evaluation and approval of the technical proposal the procuring agency, shall at a time within the bid validity period, publicly open the financial proposals of the technically accepted and qualified bids only. The financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders.

#### TERMS AND CONDITIONS OF THE TENDER

#### 3. **Definitions**

- **3.8.** . "Procuring Agency/ Purchaser" means University of University of Home Economics, Lahore.
- **3.9.** "UHE" means University of Home Economics, Lahore.
- **3.10.** . "Bidder" means the Firm/ Company/ Supplier/ Distributer that may provide or provides the Goods and related services to any of the public sector organization under the contract and have registered for the relevant business thereof.
- **3.11.** . "Contract" means the agreement entered into between the Purchaser and the Contractor, in form of Supply Order or as recorded in the Contract Form

- signed by the parties, including all Schedules and Attachments thereto and all documents incorporated by reference therein.
- **3.12.** . "Contractor/ The Successful Bidder" means the person whose Tender has been accepted and awarded letter of Acceptance followed by the Supply Order or Contract by the Purchaser.
- **3.13.** . "Contract Value" means that portion of the Contract Price adjusted to give effect to such additions or deductions as are provided for in the Contract which is properly apportion-able to the Goods or Services in question.
- **3.14.** . "Goods" means equipment, machinery, and/ or other materials which the Contractor is required to supply to the Purchaser under the Contract.
- **3.15.** . "Services" means installation, configuration, deployment, commissioning, testing, training, support, after sale service, etc. of Goods and other such obligations which the Contractor is required to provide to the Purchaser under the Contract.
- **3.16.** . "PPRA" means Punjab Procurement Regulatory Authority.
- **3.17.** If the tender opening date is announced as a holiday by the Government due to any reason, then the next working day will be considered as

tender opening date.

#### 4. TENDER ELIGIBILITY

Eligible Bidder is one who:

- **4.8.** has valid registration certificates for Income Tax and Sales Tax;
- **4.9.** is an active Income Tax Payer;
- **4.10.** has got the experience in supply of relevant items;
- **4.11.** has got the Technical Staff to execute the work;
- **4.12.** conforms to the clause of "Responsiveness of Bid" given in this tender document;
- **4.13.** has not been blacklisted.
- **4.14.** have at least five vehicles comprising of pick-up/trucks.
- **4.15.** Has at least fifteen years of work experience of provision of catering services to public or private sector.

#### 5. EXAMINATION OF THE TENDER DOCUMENT

The bidder/Tenderer is expected to examine the Tender Document, including all terms and conditions.

#### 6. AMENDMENT OF THE TENDER DOCUMENT

- **6.8.** The Purchase Committee of University of Home Economics, Lahore at any time prior to the deadline for submission of the Tender, at its own initiative or in response to a clarification requested by the Bidder(s), amend the Tender Document, onany account, for any reason. All amendment(s) shall be part of the Tender Document and binding on the Bidder(s).
- **6.9.** The Purchaser shall notify the amendment(s) in writing to the prospective Tenderers/Bidders.
- **6.10.** The Purchaser may, at its exclusive discretion, amend the Tender Document to extend the deadline for the submission of the Tender, in which case all rights and obligations of the Purchaser and the Tenderers previously subject to the deadline shall thereafter be subject to the deadline as extended.

#### 7. <u>BID CURRENCY</u>

Bidder should quote price in Pak Rupees for as tender notice.

#### 8. VALIDITY PERIOD OF THE BID

- **8.8.** Validity period of the bids shall be 90 days.
- **8.9.** In exceptional circumstances, the Purchase Committee of University of Home Economics, Lahore may ask the Bidders for an extension of the period of validity. The request and the responses shall be made in writing. A bidder accepting the request will not be required nor permitted to modify its tender.

#### 9. <u>BID SECURITY</u>

- 9.8. Bidder will submit Bid Security drawn in the name of Additional Treasurer, University of Home Economics, Lahore.
- 9.9. The Bid Security will be in form of CDR only in favor of the Additional Treasurer, University of Home Economics, Lahore.
- **9.10.** Cheque/ Cross Cheque/ pay order/ Demand Draft/Banker's Cheque shall be summarily rejected.
- **9.11.** The amount submitted as Bid Security shall be refunded to the unsuccessful bidders after the decision for the award of the said tender upon request.
- **9.12.** The Bid Security of Successful Bidder(s) may be returned after provision of services along with invoice/bill or after the submission of Performance Guarantee in the prescribed manner.
- **9.13.** If the Bid Security is found less than the required amount then the bid will be rejected irrespective of the rates and the stage of the bid process.

- **9.14.** The Bid Security may be forfeited, if a Bidder:
  - a) Refuses to accept supply order/ work order
  - **b**) Fails to furnish complete/partial supply of items.
  - c) Supplies sub-standard quality of the required item services

#### 10. BID PREPARATION AND SUBMISSION

- **10.8.** The Tender shall be filled in / accompanied by the prescribed Forms, Annexes, Schedules, Drawings, Documents, Brochures, Literature, etc. which shall be completely filled in, stamped and signed by the Tenderer or his Authorized Representative. In case of copies, photocopies may be attested.
- **10.9.** The Bids/Tenders should be submitted in two parts (1) **Technical Proposal** and (2) **Financial Proposal.** The Technical Proposal and Financial Proposal shall be submitted in separate covers.

#### 10.10. TECHNICAL PROPOSAL

The Technical Proposal will enable the concern committee to evaluate whether the bidder is technically competent and capable of executing the order and the specifications offered by the bidder meet the ones given in the Tender/Bid Documents. Only those bids which qualify in the technical stage will be eligible for the Financial Proposal opening. The Financial Proposals of bidders who failed in the Technical stage will not be opened.

- **10.11.** The Technical Proposal form as given in the Bid/Tender Document shall be filled, signed and stamped in all pages. The Purchase Committee will not be responsible for the errors committed in the bids by the bidders.
- **10.12.** The Technical Proposal **must not strictly contain any Price/Cost indications as such** otherwise the bids will be summarily rejected.
- **10.13.** The Bidder should quote only one brand/model/make of each item if required

## 10.14. <u>Detail and Order of Documents to be furnished with the Technical proposal (Envelope A):</u>

The documents attached with the Technical Bid must be signed and stamped by the Authorized Representative of the Bidder. The documents attached must be numbered and attached in the following order:

- **10.14.1.** Covering letter (*Annexure-A*) duly signed and stamped by authorized representative.
- **10.14.2.** Copy of Income Tax Registration Certificate
- **10.14.3.** Copy of PRA registration
- **10.14.4.** Detailed specification of items.

- 10.14.5. Affidavit/Undertaking Covering Letter on Stamp Paper (Annexure-D).
- **10.14.6.** If the tender documents are not purchased from purchase office of UHE and the documents are downloaded from PPRA/ UHE website then the original evidence of deposited/ transferred fee required in the concerned (deposit slip or draft etc. of Rs. 1000 must be attached).
- **10.14.7.** Evidence of bid security (CDR). Bid Security of amount (total amount of the relevant lot) mentioned in Clause No. 9 of the Tender Document
- **10.14.8.** All others supporting documents regarding required specifications and for fulfilling Technical Evaluation criteria proving the requisite qualification, experience and capacity etc.
- **10.14.9.** Signed and stamp copy of bid documents.

#### FINANCIAL PROPOSAL

- **10.15.** The Financial Proposal of the bidder shall also include the price break up of taxes/duties. All taxes/duties freight charges etc. as applicable shall be responsibility of the bidders.
- **10.16.** The cost quoted by the bidder shall be kept firm and unchanged for a period specified in the Bid/Tender Documents from the date of opening of the bids. The bidder shall keep the price firm/unchanged during the period of Contract including during the period of extension of time if any.
- **10.17.** The quoted price will be inclusive of all taxes, duties, levies, insurance, freight (transportation charges), etc.
- **10.18.** The Bid is liable for rejection if Financial Proposal contains conditional offer.
- **10.19.** Vendors must quote their rates on the company letter pad / tender form according to the specifications.

#### 10.21. Sealing the Bid

and "TO" address shall be written without fail.

#### 10.22. Mode of Submission of Bids

- **10.22.1.** The Bid should be addressed to "convener Purchase Committee, University of Home Economics, Lahore" and shall reach purchase office of University of Home Economics, Lahore within given time period in tender notice.
- **10.22.2.** The Bids received after Due Date and Time or Unsealed or incomplete or submitted by Fax or Email will be summarily rejected.

#### 11. MODIFICATION/WITHDRAWAL OF THE TENDER

- **11.8.** The Bidder may, by written notice served on the Purchaser, modify or withdraw the Tender after submission of the Tender, prior to the deadline for submission of the Tender.
- **11.9.** The Tender, withdrawn after the deadline for submission of the Tender and prior to the expiration of the period of the Tender validity, shall result in forfeiture of the Tender Security action under the rule

#### 12. **BID OPENING**

#### 12.8. Technical Proposal Opening

The bid's outer cover and Technical Proposal cover will be opened by the Purchase Committee of University of Home Economics, Lahore on the date and time as specified in the Tender Notice/Bid Data Sheet. The bids will be opened in the presence of the bidders who choose to be present. Only one representative for each bidder would be allowed to attend the Bid Opening.

#### 12.9. Suppression of facts and misleading information

12.9.1. During the bid evaluation, if any suppression or misrepresentation of information is brought to the notice of the Purchase Committee, the Committee shall have the right to reject the Bid and if it happens so after selection of the Bidder, the Purchase Committee may terminate the Contract or award of the Contract or further processing of the Bid as the case may be and that will be without any compensation to the Bidder and the Bid Security/Performance Guarantee, as the case may be, shall be forfeited along with any other legal action considered by the committee.

**12.9.2.** It is the Bidder's responsibility to prove the Bidder's requisite qualification, experience and capacity to undertake the project to the entire satisfaction of the Purchase Committee failing which the Bid may be rejected.

#### 13. PRELIMINARY EXAMINATION

- **13.8.** The Procuring Agency shall examine the bids to determine whether they are complete, whether any computational errors have been made, whether the required documents have been furnished and properly signed, and whether the bids are generally in order.
- **13.9.** In the financial bids (at the time of opening the financial proposal) the arithmetical errors shall be rectified on the following basis. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail, and the total price shall be corrected. If the Bidders/Suppliers do not accept the correction of the errors, its bid shall be rejected. If there is a discrepancy between words and figures, the amount in words shall prevail.

#### 14. <u>DETERMINATION OF RESPONSIVENESS OF THE BID</u>

- **14.8.** The Purchaser shall determine the substantial responsiveness of the Tender to the Tender Document, prior to the Tender evaluation, on the basis of the contents of the Tender itself without recourse to extrinsic evidence. A substantially responsive Bid is one which:
  - **14.8.1.** Meets the eligibility -criteria for the Bidder and the Goods / the Services;
  - **14.8.2.** Meets all the mandatory requirements of the evaluation criteria.;
  - **14.8.3.** Meets the Technical Specifications for the Services;
  - **14.8.4.** Meets the delivery period / point for the Services;
  - **14.8.5.** Is accompanied by the required Bid Security;
  - **14.8.6.** Is otherwise complete and generally in order;
  - **14.8.7.** Conforms to all terms and conditions of the Tender Document, without material deviation or reservation
  - **14.8.8.** Which offers one Brand/Model/Make for each item (which does not contain any option)
- **14.9.** A material deviation or reservation is one which affects the scope, quality or performance of the Goods or limits the Purchaser's rights or the Bidder's obligations under the Contract.
- **14.10.** The Tender determined as not substantially responsive shall not subsequently be made responsive by the Tenderer by correction or withdrawal of the material deviation or reservation. However, the Purchaser may waive off any minor non-conformity or inconsistency or informality or irregularity in the Tender.

#### 15. TECHNICAL EVALUATION CRITERIA

The Bidders who have duly complied with the Eligibility/Qualification and Evaluation will be eligible for further processing.

The Bids which do not conform to the Technical Specifications or Bid conditions or the Bids from the Bidders without adequate capabilities for supply and maintenance / warranty services will be rejected. The Eligible/Technically Qualified Bidders will be considered for further evaluation.

Technical Bids will be evaluated on the basis of following criteria and Financial Bids of only those bidders will be opened who have fulfilled the criteria:

Attach the documents required under clause No. 2.8 (c) of the bidding documents	Mandatory	

**Note:** In order to qualify for a firm / company for next phase of tender, the above are the minimum and standard requirements (successful vendor shall have to provide the sample if required by the technical committee).

The bidder must provide Verifiable documentary proof against all the mandatory requirement and Evaluation Criteria along with the Technical Proposal and no document will be received or considered after opening of the Technical Proposal.

The Purchase Committee may ask for physical Demonstration of any of the items given in the Tender Document for confirmation of the specifications.

#### 16. FINANCIAL PROPOSAL EVALUATION

- **16.8.** Technically qualified/successful bidder(s)/Tenderer(s) shall be called for opening of the Financial Proposal(s). The Financial Proposals will be opened in the presence of the Bidders at the time and venue indicated by the Purchaser accordingly. The technically Eligible/Successful Bidder(s)/Tenderer(s) or their authorized representatives against the quoted item(s) shall be allowed to take part in the FinancialProposal(s) opening against their relevant Lot(s).
- **16.9.** Financial Proposal evaluation will be conducted under the Punjab Procurement Rules,

- 2014. The Price evaluation will include all duties, taxes, freight and expenses etc. In case of any exemption of duties and taxes made by the Government in favor of the Purchaser, the contractor shall be bound to adjust the same in the Financial Proposal.
- **16.10.** The bidder must have to quote all the items given in the documents for which the bidder is applying.
- **16.11.** The tender will be awarded to the accumulated technically evaluated lowest bidder.

#### 17. REJECTION AND ACCEPTANCE OF THE TENDER/BID

**17.8.** The Purchaser shall have the right, at his exclusive discretion, to increase / decrease the quantity of the item(s), under PPRA Rules 2014 without any change in unit prices or other terms and conditions, accept a Tender reject any or all tender(s), cancel / annul the Tendering process at any time prior to award of Contract, without assigning any reason or any obligation to inform the Tenderer of the grounds for the Purchaser's action, and without thereby incurring any liability to the Tenderer and the decision of the Purchaser shall be final.

#### 17.9. The Tender / bid shall be rejected if:

- **17.9.1.** It is substantially non-responsive; or
- **17.9.2.** The bidder does not meet any of the mandatory criteria mentioned in Clause No. 15; or
- **17.9.3.** It does not contain the documentary proof against any of the mandatory criteria mentioned in Clause No. 15; or
- **17.9.4.** The bid is incomplete, partial, conditional, alternative, late; or
- 17.9.5. the bidder does not attach Bid Security in Shape of CDR; or
- **17.9.6.** the bid security is not attached or it is less than the required amount; or
- **17.9.7.** the Bidder submits more than one Bids against one Tender; orthe Bidder tries to influence the Tender evaluation / Contract award; or
- **17.9.8.** the Bidder engages in corrupt or fraudulent practices in competing for the Contract award; or
- **17.9.9.** there is any discrepancy between bidding documents and bidder's proposal i.e. any non-conformity or inconsistency or informality or irregularity in the submitted bid; or
- **17.9.10.** The Bidder submits any financial conditions as part of its bid which are notin conformity with tender document.
- **17.9.11.** If the bidder is black listed.
- **17.9.12.** Prices offered should be for the entire quantity demanded; partial quantity offers would be straightaway rejected.

#### 18. <u>CONTACTING THE PROCURING AGENCY</u>

- **18.8.** No Bidder shall contact the Purchase Committee of University of Home Economics, Lahore on any matter relating to its bid, from the time of the bid opening to the time the Contract is awarded.
- **18.9.** Any effort by a Bidder to influence the Procuring Agency in its decisions on bid evaluation, bid comparison, or Contract Award will disqualify the bidder and rejection of the bid. Canvassing by any Bidder at any stage of the Tender evaluation is strictly prohibited.

#### 19. ANNOUNCEMENT OF EVALUATION REPORT

The Procuring Agency shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of Contract. The report shall be made available on PPRA website and all the bidders shall be informed of this.

#### 20. AWARD OF CONTRACT

**20.8.** The Tender will be awarded to the accumulated technically evaluated lowest bidder who has been declared Technically Qualified as well as lowest in price on the whole.

#### 21. REFUND OF BID SECURITY (BS)

The BS of the unsuccessful Bidder will be refunded on the written request of the Bidder. The Bid Security of the successful bidder shall be released after successfully completion of service delivery or after the verification of the submitted required performance guarantee.

#### 22. <u>ISSUANCE OF SUPPLY ORDER OR SIGNING THE CONTRACT</u>

- **22.8.** On the recommendation of the purchase committee supply order will be awarded by the Treasurer Office and the contract will be signed with the successful bidder.
- **22.9.** The Successful Bidder will provide the stamp paper of 0.25% of total order value or as applicable for the time being for issuance of Supply Order or Signing the Contract.

#### 23. REDRESSAL OF GRIEVANCES BY THE PROCURING AGENCY

- **23.8.** Any bidder feeling aggrieved by any act of the procuring agency after the submission of his bid may lodge a written complaint concerning his grievances not later than 10 days after the announcement of the bid evaluation report.
- **23.9.** The committee shall investigate and decide upon the complaint within fifteen days of the receipt of the complaint.
- **23.10.** Mere fact of lodging of a complaint shall not warrant suspension of the procurement process.
- **23.11.** Any bidder not satisfied with the decision of the committee of the procuring agency may lodge an appeal in the relevant court of jurisdiction in Lahore only.

#### GENERAL CONDITIONS OF CONTRACT / SUPPLY

#### **ORDER**

#### 24. <u>DELIVERY OF SERVICES</u>

- **24.8.** Delivery Period will be counted after issuance of work order:
- **24.9.** The Supplier will be responsible for **delivery / installation/ training (if required)** of services at UHE, Lahore as mentioned.
- **24.10.** The supplier will bear all costs associated with the preparation, delivery, installation and training etc. of the Items required for service delivery and the Purchaser will in no case be responsible or liablefor those costs. The supplier will make such arrangements to ensure the safe delivery of goods required for provision of services. Any damage sustained during transportation/delivery will be rectified by thesupplier at his cost.

#### 25. LIQUIDATED DAMAGES

- **25.1.** When the supplier fails to deliver or install the goods or both within the time period specified in the contract, the Purchase Committee may, without prejudice to any other remedy it may have under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to 0.1% of the price of the delayed goods per day of delay, maximum up to 10% of the price of total value of the contract.
- **25.2.** The Successful Bidder will be responsible to provide the delivery, delivery Challan and Bill with Sales Tax Invoice within the delivery period in order to avoid Late Delivery Charges/ delay in payments.

#### 26. Sample Approval:

**26.1.** The bidder will be bounded to provide samples if required by the concerned committee.

#### 27. <u>INSPECTION AND TESTS</u>

- **27.1.** The Inspection Committee of UHE shall inspect and test the Goods supplied, the Services provided, under the Contract/Supply Order, to verify their conformity to the Technical Specifications.
- **27.2.** Inspection Committee may verify the authenticity of items from Supplier.
- **27.3.** After the inspection or test if the Inspection Committee is of the opinion that items do not conform to the specifications and the criteria mentioned above, the Inspection Committee may reject them, and the supplier shall either replace the rejected goods or make all alterations necessary to meet the requirements of the specifications free of cost to UHE.

**27.4.** The Technical Committee/ Inspection Committee can visit the workshop/ factory/ work place etc. for inspection purpose.

#### 28. RELEASE OF PERFORMANCE SECURITY

The performance security 10% will be refunded to the supplier after successful provision of the services agreed in the contract. (if not mentioned then it will be six months). The performance security must be provided by the lowest technically evaluated bidderat the time of making the contract with UHE.

#### 29. CONTRACT AMENDMENT

- **29.1.** The Purchaser may, at any time, by written notice served on the Contractor, alter, amend, omit, increase, decrease or otherwise change the nature, quality, quantity and scope, of all / any of the Goods / the Services / the Works, in whole or in part.
- **29.2.** No variation in or modification in the Contract shall be made, except by written amendment signed by both the Purchaser and the Contractor.

#### 30. TERMINATION FOR DEFAULT

The Purchase Committee of University of Home Economics, Lahore may, without prejudice to any other remedy for breach of Contract, by written notice of default sent to the tenderer, terminate this Contract in whole or in part if:

- **30.1.** The bidder fails to provide services at the time specified in the Contract
- **30.2.** the successful bidder fails to deliver services as per its technical specifications offered in the bid
- **30.3.** The successful bidder fails to perform any other obligation(s) under the Contract.
- **30.4.** The bidder, in the judgment of the Purchase Committee has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

#### 31. BLACK LISTING

If the Contractor fails / delays in performance of any of the obligations, under the Contract / supply order, violates any of the provisions of the Contract / Letter of Acceptance, commits breach of any of the terms and conditions of the Contract / Letter of Acceptance or found to have engaged in corrupt or fraudulent practices in competing for the award of contract / Letter of Acceptance or during the execution of the contract / Letter of Acceptance, the Purchaser may without prejudice to any other right of action / remedy it may have, blacklist the Contractor, either indefinitely or for a stated period, for future tenders in procuring agency or the public sector, as per mechanism provided in Punjab Procurement Rules, 2014.

#### 32. Force Majeure

Majeure means an act of nature or an event beyond the control of the Supplier and not involving the Supplier's fault or negligence directly or indirectly purporting to miss-planning, mismanagement and/or lack of foresight to handle the situation. Such events may include but are not restricted to acts of the Procuring Agency in its sovereign capacity, wars or revolutions, fires, floods, earthquakes, strikes, epidemics, quarantine restrictions and freight embargoes. If a Force Majeure situation arises, the Supplier shall promptly notify the Procuring Agency in writing with sufficient and valid evidence of such condition and the cause thereof. The Committee constituted for grievances, shall examine the pros and cons of the case and all reasonable alternative means for completion of purchase order under the Contract and shall submit its recommendations to the competent authority. However, unless otherwise directed by the Procuring Agency in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical and shall seek reasonable alternative means for performance not prevented by the Force Majeure event.

#### 33. TERMINATION FOR INSOLVENCY

The Procuring Agency may at any time terminate the Contract by giving written notice of 30 days' time to the Supplier if the Supplier becomes bankrupt or otherwise insolvent. In this event, termination shall be without compensation to the Supplier, provided that such termination shall not prejudice or affect any right of action or remedy which has accrued or shall accrue thereafter to the Parties.

#### 34. FORFEITURE OF PERFORMANCE SECURITY

- **34.1.** If the Contractor fails / delays in performance of any of the obligations, under the Contract / violates any of the provisions of the Contract / commits breach of any of the terms and conditions of the Contract the Purchaser may, without prejudice to any other right of action / remedy it may have, forfeit Performance Security of the Contractor.
- **34.2.** Failure to supply required items/services within the specified time period will invoke penalty as specified in this document. In addition to that, Performance Security amount will be forfeited and the company will not be allowed to participate in future tenders as well.

#### 35. PAYMENT

100% payment will be made by University of Home Economics, Lahore to the Successful Bidder after successful delivery, installation and training etc. of services as per schedule of delivery mentioned in the work order and on receipt of the following documents.

#### **Rate Contract**

- **36.1.** The rate contract will be initially valid uptil 30-06-2024 from the date of issue of order/approval. However, the contract will remain enacted subject to satisfactory performance.
- **36.2.** Any parallel rate contract for similar services can be placed by the University of Home Economics at any time during the period of rate contract with one or more firms.

#### 37. Work Experience Required

- **37.1.** The catering firm/ bidder must have catering experience of minimum 15 years of education sector-public or private, especially the experience of managing the events of convocation, seminars and training sessions.
- **37.2.** The catering firm/bidder must attach satisfactory certificate(s) of similar functions/ events/ parties where the catering firm has provided catering services.

#### **NOTE**

All the process will be accomplished as per PPRA Rules 2014.

Moreover, in case of any dispute / confusion etc. (other than warranty and bid security clause) the terms and conditions etc. given in Standard Bidding Document of PPRA will be applicable upto the extent of contradiction.
